

# **AGREEMENT OF COOPERATION**

### **Article I**

#### **Purpose of the Agreement**

Korea National University of Arts in Korea and State Institute of Arts and Culture in Uzbekistan, aiming to enhance the cooperation between their two universities and to develop academic and cultural interchange and other activities between their countries, agree as follows:

To develop bilateral cooperation between their two institutions in the fields of education, art and research. With this goal in mind, both institutions agree to carry out the following activities:

1. Joint artistic projects
2. Participation in seminars and academic meetings.
3. Exchange of students and faculty members.
4. Exchange of academic materials and information.

Specific programs shall be subject to mutual consent, availability of funds, and approval of each university. The terms of such mutual agreements shall be discussed and agreed upon in writing by both parties prior to the initiation of any particular program.

## Article II

### Duration of the Agreement

This agreement shall be effective upon signing by both parties and may be terminated by either side at any time, by the provision of written notice six months in advance of its intention to terminate in the agreement in original or amended form. In such a case, both parties will take the necessary measures to complete activities already in progress.

## Article III

### Copyright

Copyright and other rights in the nature of copyright, including patents, will be managed in accordance with the policies and procedures of the institution whose personnel have carried out the work in which ownership is being asserted. This will not prevent due recognition being given to those who have collaborated in the execution of the work

Publications of various kinds (articles, pamphlets, websites, etc.) as well as joint projects and diffusion that would be generated as a result of this instrument will be carried out by mutual consent.

It is expressly understood that both parties may use the results obtained from the activities authorized by the present document in their academic work with appropriate acknowledgement of ownership.

## Article IV

### Resolution of Disputes

This agreement is made in good faith by virtue of which any conflict that may arise with respect to its interpretation, formalization and fulfillment will be resolved by agreement between the parties.

Article V  
Concluding Provisions

This agreement is prepared 2 copies in English(one copy for each). Any future changes or additions to this agreement, in the form of amendments, will be made in writing and approved by both contracting parties.


